Minutes of the February 8, 2023 meeting was presented. At this time, a motion was made by Marc LaRowe to accept the minutes of the January meeting. This motion was seconded by John Chiesa and along with a unanimous favorable vote, the motion carried.

Treasurer's Report:

The Treasurer report was presented and hereby made part of the minutes of this meeting. At this time, a motion was made by Paul Carlucci to accept the treasurer's report. This motion was seconded by Marc LaRowe and along with a unanimous favorable vote, the motion carried. The reports of receipts, encumbrances and disbursements were presented and attached and hereby made part of the minutes of this meeting.

Bills:

The Bills as listed on the disbursement sheet were presented and hereby made part of the minutes of the meeting. At this time a motion was made to pay the bills totaling \$41,162.98 by Marc LaRowe. This motion was seconded by Craig Bailey and along with a unanimous favorable vote, the motion carried.

Captain, Joseph Hornsby, noted his prior request to the Commissioners, which was approved, for the purchase pants to go with the job shirts (that were purchased by members) and work boots that could be worn with

New Business:

John mentioned the need to purchase more checks and that because of how the checks are ordered, the fire department would pay for the checks and receive reimbursement from the Commissioners. Motion was made by John Chiesa to proceed with such method of payment. The motion was seconded by Marc LaRowe and along with a unanimous favorable vote, the motion carried.

Chief's Report:

Chief Max Jason advised the board of the ongoing issue with the foam system on Engine 48-2. He requested that the pump be sent to Fire Apparatus to diagnose the problem. Motion was made by Craig Bailey to proceed. The motion was seconded by Marc LaRowe and along with a unanimous vote, the motion carried. Chief mentioned that the trucks need to be serviced. John Chiesa moved to have the trucks serviced. The motion was seconded by Craig Bailey and along with a unanimous favorable vote, the motion carried. Chief stated that fit tests need to be performed and requested that the department use the same company as last year. John Chiesa made a motion to approve the request. The motion was seconded by Marc LaRowe and along with a unanimous favorable vote, the motion carried. On behalf of the Chief, Captain Hornsby requested a life vest and water rescue ropes at a cost of \$896.00. John Chiesa moved to approve the purchase. The motion was seconded by Craig Bailey and along with a unanimous favorable vote, the motion carried.

Public Comment:

The members of the public had no comments. At this time a motion was made by Marc LaRowe to close the public portion. This motion was seconded by John Chiesa and along with a unanimous favorable vote, the motion carried.

Commissioners Comments:

Paul Carlucci commented that the LOSAP payment for 2022 was submitted.
